**2. HAZARDS IDENTIFICATION**

**Main hazards:** Extremely flammable. Harmful to aquatic organisms, may cause long-term adverse effects in the aquatic environment.  
**Other hazards:** In use, may form flammable / explosive dust-air mixture.

**3. COMPOSITION / INFORMATION ON INGREDIENTS**

**Contains:** PROPRIETRY BLEND OF ALPHATIC HYDROCARBON SOLVENTS ( LOW HEXANE ).  
BUTANE.

**4. FIRST AID MEASURES (SYMPTOMS)**

**Skin contact:** There may be mild irritation at the site of contact.  
**Eye contact:** There may be irritation and redness.  
**Ingestion:** There may be irritation of the throat.  
**Inhalation:** There may be irritation of the throat with a feeling of tightness in the chest.

**4. FIRST AID MEASURES (ACTION)**

**Skin contact:** Remove all contaminated clothes and footwear immediately unless stuck to skin. Drench the affected skin with running water for 10 minutes or longer if substance is still on skin.  
**Eye contact:** Bathe the eye with running water for 15 minutes. Consult a doctor.  
**Ingestion:** Do not induce vomiting. If conscious, give half a litre of water to drink immediately. Consult a doctor.  
**Inhalation:** Remove casualty from exposure ensuring one's own safety whilst doing so. Consult a doctor.

**5. FIRE-FIGHTING MEASURES**

**Extinguishing media:** Alcohol resistant foam. Water spray. Carbon dioxide. Dry chemical powder.  
**Exposure hazards:** Highly flammable. In combustion emits toxic fumes. May form flammable / explosive dust-air mixture.

**Protection of fire-fighters:** Wear self-contained breathing apparatus. Wear protective clothing to prevent contact with skin and eyes.

## 6. ACCIDENTAL RELEASE MEASURES

**Personal precautions:** Refer to section 8 of SDS for personal protection details. Notify the police and fire brigade immediately. Eliminate all sources of ignition.

**Environmental precautions:** Do not discharge into drains or rivers.

**Clean-up procedures:** Transfer to a closable, labelled salvage container for disposal by an appropriate method. Do not use equipment in clean-up procedure which may produce sparks.

## 7. HANDLING AND STORAGE

**Handling requirements:** Smoking is forbidden. Use non-sparking tools. Ensure there is sufficient ventilation of the area. Avoid the formation or spread of dust in the air.

**Storage conditions:** Store in cool, well ventilated area. Keep container tightly closed. Keep away from sources of ignition. Prevent the build up of electrostatic charge in the immediate area. Ensure lighting and electrical equipment are not a source of ignition.

**Suitable packaging:** Must only be kept in original packaging.
